

EXHIBIT B - MINIMUM REQUIREMENTS

The following are **minimum** requirements for installations of 10 users or less. For larger installations please contact our Tech Support Dept.

I: INDIVIDUAL WORKSTATION (PC) REQUIREMENTS

A. Minimum hardware required

- 4 GB RAM, 10 GB hard drive, 1366x768 display (1920x1080 recommended), internet connection, 100Mbps NIC

B. Minimum Software required

- Microsoft Windows 7 SP1/8/8.1/10 *
- Optional: Microsoft Word 2010/2013 for custom word documents
- Optional: Microsoft Outlook 2010/2013 for email/fax via Outlook
- Optional: Microsoft Excel 2010/2013 for exporting grid data
- Foxit PDF Reader for built in reports (FREE)
- .NET Framework 2.0 SP2, 3.5 SP1, 4.0, 4.5 (FREE)

II: SQL SERVER CONFIGURATION

The following are the minimum requirements when hosting your own server (on-premises or in the cloud).
ICCO offers a hosted SQL Server option which takes care of these requirements for you.

A. Minimum server hardware required

- 4 GB RAM, 100 Mbps Network Card, 2 GHz processor
- 50 GB hard drive for up to 5 users (For 5+ users follow our SQL Server guidelines)
- Network connection to the Microsoft SQL Server:
 - On-premises option: 100 Mbps LAN
 - Cloud option: 1.5 Mbps internet connection (for up to 10 users)

B. Minimum Software required

- Microsoft Windows Server 2008R2/2012/2012R2 *
- Microsoft SQL Server 2012 **
- Server setup on the domain and domain users granted access using Integrated Security
- Microsoft SQL Server Reporting Services Installed and Configured
- .NET Framework 2.0 SP2, 3.5 SP1, 4.0, 4.5 (FREE)

III: ADDITIONAL REQUIREMENTS FOR OPTIONAL WEB INTERFACE

A. Minimum server hardware required

- Similar to II A. Separate web server recommended.

B. Minimum Software required

- .NET Framework 2.0 SP2, 3.0 SP2, 3.5 SP1, 4.0, 4.5 (FREE)
- Internet Information Services (IIS) 7.5/8.0/8.5
- SSL Certificate (for HTTPS secure connection)

IV: REQUIREMENTS FOR REMOTE SUPPORT AND INSTALLATION

LogMeIn or Terminal Services through a fast internet connection to allow ICCO remote access to the Program and Database to perform installation and support services.

V: OTHER CONSIDERATIONS

- Customer is responsible for setting up and maintaining in working order ALL the hardware and software specified in this Exhibit B.
- Customer is responsible for backing up the data and system files on the server and clients (workstations).
- Minimum technical requirements reflect the minimum hardware and software required to run the Program on a single user license.
- For recommendations on a multi-user environment please contact our technical support department.
- Generally, the latest service packs from Microsoft are required. ICCO will notify customer otherwise.

** All editions supported except SQL Express Edition. Standard or Enterprise Edition recommended.
